AN ORDINANCE OF THE CITY OF PEVELY, MISSOURI, DECLARING THAT STREET NAMED “PEGGY COURT” BE CHANGED TO “BANKS DRIVE” TO PROTECT THE HEALTH AND SAFETY OF THE CITIZENS OF PEVELY, MISSOURI

WHEREAS, the Board of Aldermen of the City of Pevely, Missouri (the “City”), after two public hearings, has determined that the location and layout of Peggy Court causes confusion to the Citizens of the City and the emergency service providers of the City of Pevely because of its location and layout such that it constitutes a public health and safety issue; and,

WHEREAS, the Board of Aldermen of the City deem it advisable and in the best interest of the City to change the name of Peggy Court to Banks Drive to alleviate the confusion and health and safety issues; and,

WHEREAS, the City Clerk caused the Resolution of the Board of Aldermen, determining the need for the name change, to be published in the Leader, a newspaper of general circulation, for four consecutive weeks prior to this Ordinance coming before the Board of Aldermen; and,

WHEREAS, the City Administrator caused written notice of the Resolution to Change the Name of Peggy Court to be sent to the affected homeowners; and,

WHEREAS, the City Clerk received no written protests of the change in name of Peggy Court to Banks drive,

THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PEVELY, MISSOURI, AS FOLLOWS:

Section 1. The street named Peggy Court is hereby changed to Banks Drive.

Section 2. The City Clerk is hereby directed to notify all necessary government agencies of the change in name, specifically notifying the City and County 911 emergency systems and the Jefferson County Assessor’s Office.

Section 3. This Ordinance shall be in full force and effect from and after the date of its passage and approval.
